## CONDITIONS OF HIRE

1. **NO USE OF LOCKS.** The boat can navigate between Foxton Locks, Market Harborough Basin and Kibworth Top Lock.
2. HIRE DURATION: one day, 9.00 or 9.30am to 5.00 / 5.30pm, or otherwise by agreement. Late return of the boat: £30 per hour, or part thereof.
3. BOOKING. The boat is not booked until the full hire fee, and completed BOOKING FORM have been received. Major credit cards accepted; cheques (payable to Foxton Boat Services Ltd) if covered by a guarantee card. Hirers must be over 18 years.
4. **A DAMAGE DEPOSIT OF £100 cash is payable on arrival. This will be refunded provided there are no losses or damages, and the boat is returned with no third party claim. We reserve the right to deduct costs if the boat is left in a dirty condition.**
5. CANCELLATION/CURTAILMENT: The hirer shall notify the Company immediately, and if the boat can be re-let, the money will be refunded, less 20% for administration. If the boat cannot be re-let no monies will be refunded.
6. INSURANCE: Insurance of the boat, its equipment and third party liability is included in the hire charge, but the hirer is responsible for the first £100 of any claim. Hirer's personal property is not covered. The Company accepts no responsibility for loss/damage to hirer's property however caused.
7. CAR PARKING is available in the British Waterways operated Pay & Display car parks at both the bottom and top of the locks. The company accepts no liability for loss or damage to customer's vehicles or their contents.
8. FBS reserve the right to refuse to hand over the boat to any person who in our opinion is not suitable to take charge of it. In this event, all money shall be refunded in full and the hirer shall have no further claim against us. If we are unable to provide the boat, or a suitable alternative, we will refund all monies in full, and the hirer shall have no further claim against us.
9. ACCIDENTS: The hirer is solely responsible for the safe and sensible handling of the boat. Full instruction is given. Any accidents to the boat, waterway property, or to any other boat, property or person, must be reported to the company immediately.  
NO LIABILITY SHALL BE ADMITTED.
10. BREAKDOWN: The hirer shall have no claim on the company as a result of any breakdown or failure of the boat, and where such breakdown is caused by the negligence of the hirer or by failing to carry out instructions given by the company, the company shall have the right to claim in respect of rectifying the matter.
11. NO MORE THAN 12 PERSONS may be on the boat by law. Failure to comply with this will lead to confiscation of the boat.
